Guest Presenter:

Teresa Korol - seating condition in the AP Theatre. Arts Council has stepped forward to help out with funding for new seating. We have been requesting a significant amount of money from the ministry for 8 years – annually it gets submitted. For the last 3 – 5 years, YRHS has remained in the top ten. Asbestos obviously takes precedent over seating. The next item after asbestos removal is windows. Ventilation system is the third request. There are a number of building code issues that need to be attended to (Sprinkler system, new doors fire safety requirement, handrails). There are a number of roofing issues that also need to be addressed. There are a number of asbestos issues in the Theatre, so the seating was being stalled until the asbestos was removed. We could be waiting a long time for this, so we will look at seating replacement, if an abatement is in order, the seats simply will need to be taken out while the abatement happens. Changerooms in the gym – aesthetically, privacy and health wise, they need a big facelift. The track surface needs to be attended to and inspected. There is a warranty period on the resurfacing that was recently done, and so this will be looked into this spring. The lights are another item at Century Field that have been requested. All in all, there are many big projects

that need to be tackled, but we can see that the overall price tag wouldn't be small therefore a

priority list based on need, has to be in order.

MH mentioned that the security camera system needs to be considered for upgrade and

maintenance.

Teresa K will be meeting with MH to discuss our facility list and the needs of the YRHS.

out of the profit. There is not another cafeteria in the province that turns a profit (Exception of MUCC – Melfort, because their board does not consider wages / benefits of staff in the equation).

Fundraising bracelets – silicone bracelets for sale – proceeds to the Young Family.

School Van – our fleet will be down one soon, as it will be out of commission and not road

worthy.
