**PRINCIPAL'S REPORT: (see report)** In summary...Mr. Haczkevicz touched on the following topics:

**Information Items Year at a Glance:** COVID 19 sucking the life out of our school culture, annual van payment, grad assemblies done by visiting all grade 12 classrooms, cap and gown photos, SOS-Q Survey, 19 Mil \$ Renovation to YRHS, projected enrolment of 831 (776 face to face and 55 DL), Ribbon Shirt / Skirt Day declared by GSSD annually to happen on Jan. 4, Quad System was introduced for scheduling for the upcoming school year, Virtual Raider for a Day, Edsby for classroom seating plans, virtual (IG) Awards Night, Virtual Graduation, Drive-Thru Cap and Diploma Ceremony, Students declining to stand for the national anthem and the schools expected response, start of new school year with a very large turnover in staff, CSLC 2020 update – still postponed until further notice, COVID information updates continued to be shared



monthly – importance of vaccination being encouraged for staff and students, made mandatory by Nov. of 2021, and students had repercussions if they were a part of Extra-curricular activities and became a close contact and were not vaccinated, return of PLC’s and RTIME for all staff and students. October of 2021, we had 6 fire drills – some caused by vaping. YRHS began the process of reviewing and collecting information in regards to vision, mission statement planning – which will be an ongoing process for the 2021 – 22 school year.

**Achievements:** Chief Cadmus Delorme, Weight Room named after the Late Shelby Patton, Sr. Football finished 2<sup>nd</sup>, Sr. Boys’ Soccer Team captured bronze, Sr. Boys’ volleyball advanced to provincials, Kaitlyn Kelly spearheaded the Metallic Rainbow Flag – mounted on our brick wall of the front of the school.
